

**MAINTAINING YOUR INVESTMENT IN MASSY HOLDINGS LTD.
("THE COMPANY")**

Shareholders may continue to hold their shares in Massy by either;

- (i) Transferring their current shareholding from the Barbados Central Securities Depository Inc. ("BCSD" to the Trinidad and Tobago Central Depository ("TTCD"),

or

- (ii) Requesting a physical Share Certificate.

We encourage all Shareholders to take advantage of the opportunity to transfer their shares to the TTCD as the benefits of transferring include, ease of trading in the future and avoidance of having to follow the detailed procedures where a physical share certificate is lost or misplaced.

The transfer of shares from the BCSD to the TTCD will attract a fee of approximately BD\$20.00 per transfer and will be covered by the Company on Shareholders' behalf, for all transfers which take place by **December 31, 2016**.
